<b>IF THIS HAPPENS</b>	<b>DO THIS</b>
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Dial 111
Spill or Leak	Sweep up spilled product, collect and place in sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	Dial 111. Wear full protective clothing and breathing apparatus. Use fog, foam, powder or CO <sub>2</sub> to extinguish. Cool steel drums with water to prevent explosion by thermal expansion. Contain run-off.
