IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Dial 111
Spill or Leak	Sweep up spilled product, collect and place in sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	Dial 111. Wear full protective clothing and breathing apparatus. Use fog, foam, powder or CO ₂ to extinguish. Cool steel drums with water to prevent explosion by thermal expansion. Contain run-off.

FIRST AID

If Swallowed	Do NOT induce vomiting. For Advice contact the National Poisons Centre 0800 POISON (0800 764 766) If symptoms develop call a doctor.

If On Skin	Wash affected areas thoroughly with soap and water. If symptoms develop seek medical advice.
If Inhaled	Remove from exposure. Allow patient to assume the most comfortable position and keep warm. Seek medical advice if symptoms develop.
