EMERGENCY PROCEDURES

IF THIS HAPPENS DO THIS Tanker/Vehicle Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Accident Spill or Leak Sweep up spilled product, collect and place in sealable container for disposal. Seek advice from the local authority regarding disposal. Fire Dial 111. Wear full protective clothing and breathing apparatus. Use fog, foam, powder or CO2 to extinguish. Cool steel drums with water to prevent explosion by thermal expansion. Contain run-off.
